Management Reports

MicroMD PM management reports help you measure actual day-to-day operations in order to serve patients more effectively and run your practice more efficiently. For example, diagnosis and procedure history reports capture detailed encounter data and display it by provider, group of providers, location, service date range, posting date range, or other criteria. These reports can help you identify trends and ensure proper coding.

For useful insight into productivity of the provider, MicroMD PM can present the financial data in the standard report format, detailing the total charges, payments write-off and refunds posted for the provider. The system can also display this information in a graphical format to present with any monthly or yearly reports. Patient recall reports, sorted by patient ID, name, date, number of recalls, provider, or reason help you manage the task of tracking and managing follow-up visits.

Financial Reports

MicroMD PM financial reports are tools to manage the health of your practice's cash flow. The accounts receivable summary presents an "at-a-glance" snapshot of current AR the way you want to see it: by day, by month, for a specified time period, in a table, or as a graph. A variety of collection reports help you manage patient financials and insurance payments more smoothly.

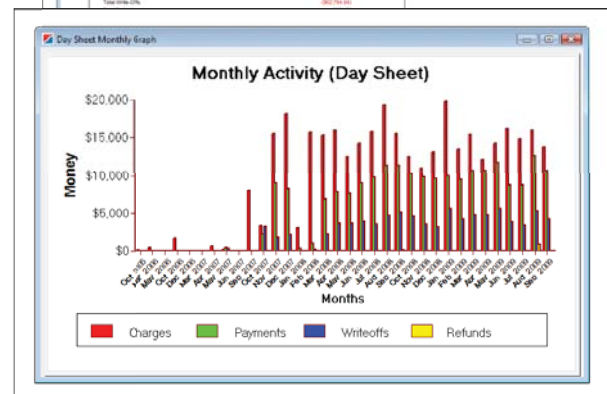
Administrative and Other Reports

Resource-based Relative Value Scale (RBRVS) Reporting

MicroMD PM enhanced reporting capabilities help you benchmark the business of your practice by indicating the relative value of procedures your practice performs. Medicare data is incorporated into the MicroMD database, which includes work RVUs, malpractice RVUs and physician expense RVUs for both practice location and the service facility. MicroMD PM has the ability to assign the CMS carrier location to service facilities and practice locations, which allow your practice to generate details about the provider work, practice expense and malpractice values for procedures performed by your practice.
